Where is my dollar going?

**CREDIT VS. DEDUCTION**

A deduction helps to determine your final taxable income. A credit is a reduction in your tax liability— so, if you're getting a refund, you'll also get back the credit amount. If you owe, the credit is applied to what you owe, decreasing that amount you'll later have to pay.

**HOW MUCH CAN I GIVE?**

Any amount from \$25 to \$200 if you're single or up to \$400 for married filing jointly.

**HOW DO I GET IT BACK?**

Complete the form to the right and mail it along with your donation. You'll receive a receipt detailing your generosity. When preparing your taxes, complete a simple Az form 321.

**HOW CAN I LEARN MORE?**
